I would also like to thank John Ace for the very professional way he handled the confrontation with the former club member, as well as Mike Shauger. Their actions were correct and placed us on a strong footing with the state. If the State wants to give permission to fly Drones, that is their prerogative, but our last conversation with them was a very loud "NO". The state's policy is that the flying of Drones on state park land is not permitted. We must uphold that policy until advised otherwise.

I will have more to say about this issue at our next meeting, but I assure you that we will be flying at Squatrito in 2016. What happens next year is subject to the State's needs as I have advised the membership earlier?
