Treasurers Report:

The opening balance was \$12,295.71. The closing balance was \$13,045.00.

Field Reports:

Both fields are in good flying shape. Watch out for hunters at Hardyston field.

Old Business:

There were no new nominations from the membership. Nominations were closed for 2016.

Pat opened up discussion on the new field. He mentioned that we met with Josh. Grading the runway was completed, the field was raked, and seed was put down. The road and culvert are done. The runway is not real wide and there is a problem with the pit area. We will have to resolve with club funds.

We are permitted to use Squatrito while the new field is being developed. There is one stipulation. We have to have all of our benches and our hut gone by <u>May 1st 2017</u>. We can use pop ups and portable flight stations.

There will be a meeting on October 29th to develop a plan and budget.

Josh commented that a substantial amount of resources were committed to this project. Discussions followed.

New Business:

Anthony mentioned that you no longer need to send in a copy of your AMA membership card when renewing you club membership. He will provide a list of members who did not pay to Craig. While you can still pay your dues, you cannot fly or receive your new membership card until you pay your AMA dues. AMA membership policy has changed. Memberships are from when you join rather than January to December. Anthony will get a notice that AMA memberships have expired during the year. If you do not pay, you will receive notice that you are suspended from flying until you pay your AMA dues.

Treasurer's Report:

September's opening Balance is \$12,295.71. Collections for the month totaled \$1,985.00 represented by AMA Picnic Revenue \$1,941.00 and 50/50 of \$44. Expenses for the month totaled \$1,235.60 represented by Mowing \$510.00, September BBQ \$56.00, mowing of new field \$170.00 and AMA Picnic \$499.60. The result is an ending balance of \$13,045.11

A recap by category as they currently stand follows:

Encumbered for Club Business \$1,588.00
General Reserve \$4,166.00
Warbirds \$945.00
Laser/Electric/AMA Picnic \$6,346.00
Total \$13,045.00

The encumbered amount of \$1,833.00 is very tight for meeting the clubs remaining operating expenses and will be short if we have to mow in November. It is very possible we will need to use some reserves before the end of the year.

The AMA Picnic Revenue and Expenses represent the remaining balances deposited and expended during the month of September. A recap of the activity shows total collections of \$5,872 and expenses of \$1,790 resulting in a gain of \$4,082.

The reserves will be reviewed at the October meeting and reallocated to provide funding for the new field.
